2006 Tax Reporting Information

PIMCO Municipal Income Fund II

For the year ended December 31, 2006, substantially all income dividends paid were derived from obligations exempt from federal income tax. During 2006, PIMCO Municipal Income Fund II invested in market discount municipal bonds, whose accretion is taxable. Accordingly, 9.18% of dividends paid were taxable. For 2006, 0% of dividend income was subject to the alternative minimum tax ("AMT"). Shareholders should consult their tax advisors as to the state and local status of dividend income received.

The information below may be of value in reducing a shareholder's state or local tax liability, if any, in connection with dividend income received from PIMCO Municipal Income Fund II.
