To sign up for an **existing** PIMCO Funds & Allianz Funds account, simply complete the enclosed Fund Link Enrollment Form. If you're linking your fund account to your bank checking account, please include an unsigned voided check. If you're linking your fund account to your bank savings account, enclose a personalized deposit slip that has your bank account number encoded on it, as well as an ABA number.

For your protection, if you'd like to use Fund Link to have money transferred to your bank account (Section 3), we'll need to have your signature guaranteed in Section 6.

To sign up for a **new** PIMCO Funds & Allianz Funds account, do not complete the enclosed form. Please complete the regular PIMCO Funds & Allianz Funds Application (that accompanies the prospectus), including the Fund Link section. Mail the application form to Allianz Global Investors Distributors LLC. Be sure to read the prospectus carefully before investing or sending money, as it contains more detailed information, including charges and expenses.

Shares will be purchased on the regular business day the Distributor receives the funds through the ACH system, provided the funds are received before the close of regular trading on the New York Stock Exchange. If the funds are received after the close of regular trading, the shares will be purchased on the next regular business day.
