

PIMCO Funds & Allianz Funds IRA Change of Beneficiary Form

The following form may be used only to designate a beneficiary(ies) or to change a designation of beneficiary(ies) for a PIMCO Funds & Allianz Funds Individual Retirement Account (IRA) for which Boston Financial Data Services, Inc. serves as transfer agent for the IRA Custodian. The designation must be received by Boston Financial Data Services, Inc. as agent for the IRA Custodian, and replaces any previously submitted beneficiary designation including the designation contained in the IRA Application establishing the IRA.
